Dr. Norman Ouzts, NBCE CEO, presented the 2023 Paul M. Tullio Award to Dr. Mark Bronson. Dr. Bronson provided brief remarks and appreciation on acceptance of the award.

The Delegate Assembly recessed for lunch with instructions for the Delegates and Alternate Delegates to report to their respective tables at 1:15pm EDT.

Dr. David Wickes, Chair of the Association of Chiropractic Colleges, was acknowledged.

The 2023 NBCE Annual Meeting of Delegates was called back to order from recess at $1.56 \mathrm{pm}$.

Dr. James Buchanan, NBCE District I Director and Credentials Committee Chair, presented the committee report indicating 39 delegates were registered and in attendance, 8 alternate delegates were registered and in attendance and moved for adoption of the report (motion carried).

The 2022 NBCE Annual Meeting of the Delegates Minutes were approved without objection or correction. The 2022 Special Meeting of Delegates Minutes, held in August 2022, were approved without objection or correction.

NBCE Treasurer, Dr. Marty Freihaut, delivered a treasurer's report and acknowledged that a copy of the NBCE's 2021 and 2022 Independent Certified Public Accountant Audit was posted to the NBCE's website. NBCE's 2022 Financial Audit was conducted in March 2023 by the independent accounting firm of Brock and Company, Certified Public Accountants. The independent auditor's letter of opinion affirmed NBCE's financial statements present favorably, and all material represents the financial position of the NBCE as of December 31, 2022. It was moved on behalf of the Board of Directors to accept the auditor's report (motion carried).

Dr. Jason Jaeger, NBCE District IV Director and Bylaws Committee Chair delivered a report on behalf of the committee discussing the work of the committee to generate a general revision of the NBCE Bylaws. It was moved that the general revision of the NBCE bylaws be ratified (motion carried).
