

NATIONAL BOARD OF CHIROPRACTIC EXAMINERS
2024 ANNUAL BUSINESS MEETING

The Annual Meeting of the National Board of Chiropractic Examiners (the “NBCE”) was held on Friday, May 3, 2024, at the Renaissance Phoenix Downtown Hotel in Phoenix, AZ. Dr. Karlos Boghosian, NBCE President, was present and presided over the meeting calling it to order at 12:00pm with Dr. LeRoy Otto, NBCE Secretary, present and serving.

Dr. Gary DiBenedetto, NBCE District III Director, provided an invocation.

Dr. Danita Thomas Heagy, NBCE District V Director, led the assembly in the pledge of allegiance.

Dr. Karlos Boghosian provided opening remarks covering highlights from the previous year, personal reflections, and the importance of examinations in the chiropractic profession.

The meeting recessed for lunch at 12:50pm and returned from recess at 1:34pm.

Dr. James Buchanan, NBCE District I Director and Credentials Committee Chair, presented the committee report indicating 34 delegates were registered and in attendance and moved for adoption of the report (motion carried).

The standing rules were adopted as presented without objection.

The agenda was adopted without objection.

After presentation of the 2023 transcript and the NBCE 2023 Annual Business Meeting minutes the minutes were approved as presented.

The 2024 Minutes Advisory Committee (District I – Vincent Rokke, DC/North Dakota; District II – Rebecca Ault, DC/Ohio; District III – Andrew Riddle, DC/Delaware; District IV – Rachel Klein, DC/Hawaii; District V – Jennifer Rathmann, DC/Virginia) was appointed with the NBCE Board Secretary to serve as an ex-officio member and the committee to meet in the Fall.

Melissa Stockberger, NBCE Chief Financial Officer, presented a report on behalf of the NBCE Treasurer and acknowledged that copies of the 2022 and 2023 independent audits were posted on the NBCE website, and that the NBCE had \$15.4 million in revenue and \$15.3 million in expenses, a positive \$3.2 million change in investment activities, \$49.7 million in assets and moved for adoption of the report as presented (motion carried).

Dr. Jason Jaeger, NBCE District IV Director and Bylaws Committee Chair delivered a report on behalf of the committee and moved to withdraw previously noticed bylaw amendments (motion carried).

District caucusing from District III and District V began at 1:47 pm for the purpose of nominating members for election. Ms. Jennifer Semko served as a teller for District III and Mr. Adrian Stratton served as a teller for District V. The Delegate Assembly returned from caucusing at 1:54pm and the following were nominated and subsequently elected: Dr. Gary DiBenedetto, NBCE District III Director (for a three-year term); and Dr. Danita Heagy, NBCE District V Director (for a three-year term).

Mrs. Caroline Yielding, NBCE Executive Assistant, was formally recognized for her efforts during the Annual Meeting.

After the conclusion of announcements the 2024 Annual Meeting of the National Board of Chiropractic Examiners adjourned at 1:58 pm.
